

Terms of Sale

TOGETHER

On the one hand Mr. Rubén Muñoz Marín with DNI 48572354B, and address at Avenida Conde Lumiares n° 18, 1° D. Postal Code: 03010 Alicante (Spain), as responsible main company Rubenetti Coastal Rowing and on the other hand Mr./Mrs.

INTERVENE

That both parts accept the general terms defined in the following contract, where Mr. Rubén Muñoz Marín plays the role of SUPPLIER, and in which as BUYER acts Mr./Ms.

CLAUSES

- 1. The SUPPLIER agrees to deliver the goods specified in the form order within the agreed period and with the characteristics agreed in the same form.
- 2. The specifications and prices in our catalog may vary throughout the year.
- 3. The BUYER agrees to receive the boat specified in the order form, in case of cancellation of the contract by the customer, it will retain 30% of the total order price.
- 4. The delivery date begins to count from the moment the advance payment of 50% of the order in the SUPPLIER's bank account, any change by the BUYER in the order must be notified by email, and the SUPPLIER will indicate the new delivery date.
- 5. The delivery date will count from the moment the SUPPLIER delivers the merchandise to the BUYER, or failing that to the carrier.
- 6. The SUPPLIER will notify of the preparation of the order for delivery, from then, the BUYER will have 2 weeks to receive the boat.
- 7. In the event that the delivery of the merchandise is not possible due to the absence of the BUYER, the charges that carry said return will be assumed by the own BUYER.
- 8. The merchandise will not be delivered until full payment has been received from the same.



- 9. The BUYER must ensure that the merchandise is in perfect condition before signing the receipt sheet, from which the order is made by delivered and finished.
- 10. In the case of payment in installments, the goods will remain the property of the SUPPLIER until the completion of payments, any damage or malfunction on the boat or product will be the responsibility of the BUYER. In case of non-payment, the SUPPLIER reserves the right to recover the boat and the costs that This will be assumed by the BUYER.
- 11. All products have a 2 year warranty period, except for second-hand boat. Terms of the guarantee are specified in the warranty terms.
- 12. The BUYER is obligated to report any defect in the product delivered within two days of delivery.
- 13. The SUPPLIER will have all the image and brand rights of the products delivered.
- 14. This contract is commercial in nature, governed by the provisions of its own clauses.
- 15. Both parties expressly waive their jurisdiction and submit to the Alicante courts.
